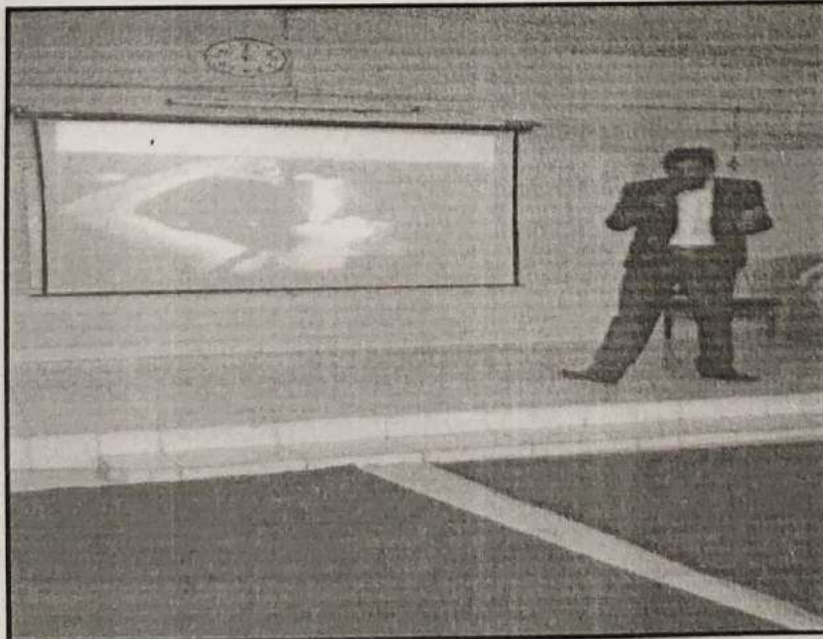
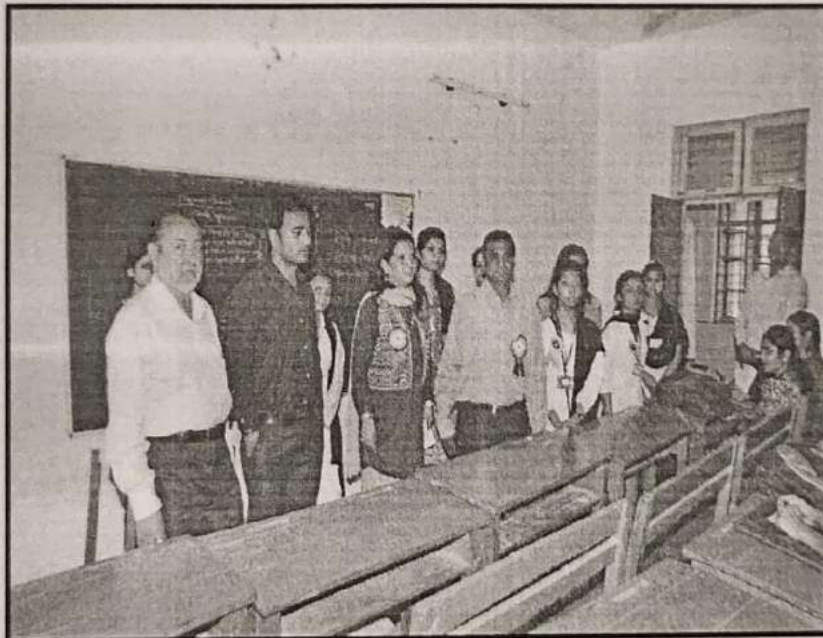

3. You are accordingly directed to report to Director, National Industrial Security Academy (NISA), Hakimpet, Hyderabad - 500078, Telangana on 12.01.2018 between 0800 hrs. to 1200 hrs. repeat on 12.01.2018 between 0800 hrs. to 1200 hrs. In case you fail to report on the stipulated date, it will be presumed that you are not interested to accept this offer and the offer of appointment **will lapse automatically.**

PAY AND ALLOWANCE

5. The initial scale of pay for the post is Rs. 35,400/- in the first cell in the Level-6 schedule (pay matrix) of Central Civil Services (Revised Pay) Rules, 2016 and your pay will be fixed at the minimum of the scale.

6. You will also be entitled to draw Dearness Allowance and other allowances at the rates as admissible in the said pay scale and for the said post subject to the conditions laid down in Rules and orders governing the grant of such allowances in the Force from time to time.

TERMS AND CONDITION

7. On your joining the post, you will be on probation for a period of two years in the first instance subject to the provision that the appointing authority may extend the same if felt necessary. If during the period of probation, the appointing authority is of the opinion that you are not fit for permanent appointment, the appointing authority may terminate you from the Force after issue of notice of one month or after giving one month's notice (whichever is less) of such notice.

8. You are liable to serve anywhere in India according to the transfer policy of the Force.
 9. You are liable to serve in NSG, SPG or any other Force of the Country in the broader interests of national security.
 10. You will be subject to the provisions of CISF Act, 1968, CISF Rules 2001 and any other rules and regulations which the Central Government may frame from time to time. The CISF Act, 1968 and CISF Rules, 2001 can be accessed at <http://www.cisf.gov.in>.
 11. The "**NEW RE-STRUCTURED DEFINED CONTRIBUTION PENSION SYSTEM**" applicable for the new entrants to the Central Government Services w.e.f. January, 2004 will also be applicable to you.
 12. In case, you tender resignation within ten years from joining of service, you shall be required to refund to the government such as would constitute the cost of training imparted to you in the Force or a sum equal to three months pay and allowances, whichever is more. 

If you are not able to report to the above mentioned training institute by the stipulated date due to unavoidable or compelling circumstances, you may submit your request with full facts/justification alongwith necessary documents in support of your request for extension to Director, NISA Hyderabad. Your request for extension should reach the Director, NISA Hyderabad on or before the reporting date failing which it will be presumed that you are not interested to join service and your offer of appointment will automatically lapse and no further correspondence will be made. In this regard, please note that such request for extension will be considered only if the same is found to be genuine due to circumstances beyond your control and decision of the competent authority shall be final and binding. There will be no appeal against the order of the competent authority.

25. You should be in possession of sufficient money of at least of Rs. 15,000/- (Rupees fifteen thousand only) for your own mess deposit and other pocket expenses in the first instance till you are paid your salary, which may take one or two months after your joining.
