- 4. Fees collected from students should be deposited with bank on daily basis.
- 5. All the Expenses and Payment are passed by the appropriate authority. We have verified the vouchers on Sampling basis.
- 6. Bank Passbook and Cashbook should be reconciled on monthly basis.
- 7. We could not be physically verified the Cash-in-hand and Fixed Asset of College.
- 8. It has been observed that per day closing of cashbook not found on various pages.
- 9. We are unable to comment on Bank Reconciliation and party Reconciliation.
